# THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM PROPERTY REGIME OF MARY SAVIO MEDICAL PLAZA AT NEWTOWN AND SECOND AMENDMENT TO BYLAWS OF THE ASSOCIATION OF UNIT OWNERS OF MARY SAVIO MEDICAL PLAZA AT NEWTOWN

WHEREAS, pursuant to that certain Declaration of Condominium Property Regime of Mary Savio Medical Plaza at Newtown dated August 13, 2012 (the "Declaration"), recorded in the Bureau of Conveyances of the State of Hawaii (the "Bureau") as Document No. A-46440570, and filed with the Office of the Assistant Registrar of the Land Court of the State of Hawaii (the "Land Court") as Land Court Document No. T-8296571, together with that certain Condominium Map, recorded concurrently with the Declaration in the Bureau as Condominium Map No. 5117, and filed with the Land Court as Condominium Map No. 2174 (the "Condominium Map"), the condominium property regime known as the "Mary Savio Medical Plaza at Newtown" (the "Project") was created pursuant to Hawaii Revised Statutes ("HRS") Chapter 514B, as amended (the "Act"); and

WHEREAS, the Declaration was amended by instrument dated July 18, 2013, recorded in the Bureau as Document No. A-49520642A, and filed in Land Court as Land Court Document No. T-8603246, with necessary joinder consented thereto through joinder recorded in the Bureau as Document No. A-49520642B, with the Declaration further amended by instrument dated March 18, 2015, recorded in the Bureau as Document No. A-55690753A, and filed in Land Court as Land Court Document No. T-9221208A, with consent thereto recorded in the Bureau as Document No. A-55690753B and filed in Land Court as Land Court Document No. T-9221208B; and

WHEREAS, the Bylaws of the Association of Unit Owners of Mary Savio Medical Plaza at Newtown governing the administration of the Project ("Bylaws") was recorded in the Bureau as Document No. A-46440571, and filed with Land Court as Land Court Document No. T-8296572; and

WHEREAS, the Bylaws was amended by instrument dated March 18, 2015, recorded in the Bureau as Document No. A-55690754A, and filed in Land Court as Land Court Document No. T-9221209A, with consent thereto recorded in the Bureau as Document No. A-55690754B, and filed in Land Court as Land Court Document No. T-9221209B; and

WHEREAS, HRS Section 514B-32(a)(11) states that the Declaration, as amended, may be further amended through approval of the owners of at least sixty-seven per cent of the common interest; and

WHEREAS, HRS Section 514B-108(e) states that the Bylaws may be amended at any time by the vote or written consent of at least sixty-seven per cent of all unit owners; and

WHEREAS, by written consent, more than sixty-seven per cent of the common interest of the Project voted in favor of amending the Declaration and Bylaws as indicated below;

NOW, THEREFORE, the Declaration and Bylaws are hereby amended as follows:

1. The name of the condominium Project is changed to "MARY SAVIO MEDICAL PLAZA AIEA PEARL CITY" and the name "MARY SAVIO MEDICAL PLAZA AIEA PEARL CITY" shall be substituted for the name "Mary Savio Medical Plaza at Newtown" wherever the latter name appears in the Declaration, the Bylaws, and the Condominium Map for the Project.

IN ALL OTHER RESPECTS, the Declaration and the Bylaws, as amended, are hereby ratified and confirmed and shall be binding upon and inure to the benefit of the parties to it and their respective and permitted assigns. The undersigned officers of the Association hereby certify that the foregoing amendment to the Declaration and Bylaws

was adopted by more than sixty-seven per cent of the common interest of the Association.

THIS AMENDMENT may be executed in counterparts, each of which shall be deemed an original, and said counterparts shall together constitute one and the same instrument, binding all of the parties hereto, notwithstanding that all of the parties are not signatories to the original or the same counterparts. Duplicate unexecuted and unacknowledged pages of the counterparts may be discarded and the remaining pages assembled as one document.
